## Anti-Money Laundering and Counter-Terrorist Financing (Financial Institutions) Ordinance Chapter 615, Laws of Hong Kong

### Guidance Notes on Form 4 Application for Approval in respect of Persons Proposing to become Licensee's Partners / Directors / Ultimate Owners

#### Part A - General Information

#### 1. Introduction

- 1.1 Under sections 35(1), 36(1) and 37(1) of the Anti-Money Laundering and Counter-Terrorist Financing (Financial Institutions) Ordinance, Chapter 615 (AMLO), whenever there is an addition of partners / directors / ultimate owners, the licensee must seek prior approval from the Commissioner of Customs and Excise (CCE) for the addition. The breach of this requirement is also subject to the imposition of disciplinary actions by the CCE and maximum penalty is a fine of \$1,000,000. The licensee may also be prosecuted and liable on conviction to a fine of \$50,000 and to imprisonment for 6 months.
- 1.2 Under section 40 of the AMLO, a licensee must notify the CCE in writing of any change in the particulars within one month beginning on the date on which the change takes place. Any breach of this requirement, without reasonable excuse, is an offence and is liable on conviction to a fine of \$50,000. **In this connection, a licensee must submit Form 6 Notification of Changes in Particulars to notify the CCE after the approved person has formally become the licensee's partner / director / ultimate owner within one month beginning on the date on which the change takes place.**
- 1.3 Ultimate owner:
- (i) In relation to a sole proprietorship:
    - (a) means another individual who ultimately owns or controls the money service business of the sole proprietor; or
    - (b) means the other person if the sole proprietor is acting on behalf of another person.
  - (ii) In relation to a partnership means an individual who:
    - (a) is entitled to or controls, directly or indirectly, not less than a 10% share of the capital or profits of the partnership;
    - (b) is, directly or indirectly, entitled to exercise or control the exercise of not less than 10% of the voting rights of the partnership; or
    - (c) exercises ultimate control over the management of the partnership.
  - (iii) In relation to a corporation means an individual who:
    - (a) owns or controls, directly or indirectly, including through a trust or bearer share holding, not less than 10% of the issued share capital of the body corporate;
    - (b) is, directly or indirectly, entitled to exercise or control the exercise of not less than 10% of the voting rights at general meetings of the body corporate; or

(c) exercises ultimate control over the management of the corporation.

## 2. **Eligibility Criteria**

- 2.1 An application for the approval of the CCE to become licensee's partner / director / ultimate owner must be made to the CCE in the specified form and manner and accompanied by the fee specified in Schedule 3 of the AMLO. For details of the application fee, please refer to the Appendix A.
- 2.2 The CCE may grant an approval under section 35(3), 36(3) or 37(3) of the AMLO only if the person in relation to whom the application is made is a fit and proper person to operate a money service.
- 2.3 In determining whether a person is a fit and proper person under section 35(3), 36(3) or 37(3) of the AMLO, the CCE must, in addition to any other matter that the CCE considers relevant, have regard to the matters specified in section 30(4)(a), (b), (c), (d) and (e). For details of the Fit and Proper Person Criteria, please refer to the Appendix B.

## 3. **Application**

### 3.1 **Application Forms**

- (i) Application forms can be obtained from the Money Service Supervision Bureau (MSSB) of the Customs and Excise Department (C&ED) at 13/F, Customs Headquarters Building, 222 Java Road, North Point, Hong Kong or 3/F, Customs Headquarters Building or downloaded from the C&ED website at <http://www.customs.gov.hk>.

- (iii) The applicant is required to submit Form 4 and 3A together with Appendices I & II for the person proposed to be licensee's partner, director and ultimate owner who is an individual. Where there is any proposed partner or director which is a corporation, an applicant is also required to submit Form 4 and 3B for such partner / director.
- (iv) For details of how to complete Form 3A and 3B, please refer to the relevant Guidance Notes.

### 3.2 **Online Application**

An applicant may submit an electronic application form through the C&ED website at <http://www.customs.gov.hk>.

### 3.3 **In person or by post**

- (i) Please note that there is no need to sign on the duly completed Form 4 when submitting it to the CCE. The applicant will be asked to sign on it during an interview with an officer of the C&ED at a later stage.

- (ii) After receiving the application submitted in person or by post, the CCE will issue an Acknowledgement of Receipt of the application within 7 working days from the submission or the postal date.
- (iii) Information provided by the applicant in the application form must be supported by copies of relevant documents. Applicant is therefore reminded to ensure that application is submitted together with all required supporting documents. Failure to do so may cause delay in processing the application, or may result in deferment or rejection of the application. For details of the required documents, please refer to the “Checklist for submission of supporting documents” in the application form.
- (iv) If there is any change to the information contained in the application after its submission, the applicant should submit a written request to the CCE promptly. Likewise, if an applicant wishes to withdraw the application, the applicant shall submit a written request to the CCE. Applicants are reminded that any amendments shall form an integral part of their applications. The supplementary information must be submitted together with copies of relevant supporting documents to the CCE.

#### **4. Processing of Application**

- 4.1 Upon receipt of an application and the relevant documents, the CCE may also request the applicant to provide additional information to process the application where necessary. Failure to do so within a period as specified by the CCE may cause delay in processing the application, or even result in deferment or rejection of the application.
- 4.2 The applicant will receive a notice for an interview together with a demand note for the payment of fees regarding the application for the approval of becoming licensee’s partner / director / ultimate owner. An application without full payment will be rejected. The fees are non-refundable irrespective whether the application is successful or not.
- 4.3 The applicant is required to bring along with him / her the notice, receipt of payment and the relevant original documents for verification during an interview with the authorized officers of the C&ED at date, time and venue as specified by the CCE. During the interview, the applicant is required, among others, to sign on the Form 4 in the presence of an authorized officer of the C&ED.
- 4.4 The accuracy of the information provided will be checked through various means which include but not limited to the information held by the C&ED, other government departments and law enforcing agencies.
- 4.5 The processing time may vary depending on various factors including the time taken in collecting the requisite documents from the applicant and the time required in obtaining records from other authorities to perform a fit and proper person test.

### **Part B - Notes on How to Complete the Application Form**

Please fill in the form in **capital letters** and **black ink** according to the instructions stated in the application form and the Guidance Notes. An illegible handwritten form may be rejected.

5. **Part 1 - General Information of the Applicant**

Please provide the information of the applicant including the MSO licence number, applicant company name and business registration number.

6. **Part 2 - Particulars of the proposed Individual to be Licensee's Partner / Director / Ultimate owner**

6.1 For the individual proposed to be licensee's partner / director / ultimate owner, please complete 3A as well as Appendices I and II.

6.2 Applicant must list out all the persons proposed to be licensee's partners and directors and ultimate owners, and have to pay a fee for fit and proper person test for each of them. If Applicant has more than one partner or director or ultimate owner, please make a photocopy of the relevant page and fill in the information as an additional sheet for each proposed partner or director or ultimate owner.

6.3 The proposed person shall make a statement that he or she has consented to be licensee's partner / director / ultimate owner subject to the approval to be granted by the CCE in respect of the application. He or she should sign the "Consent to act as a partner / director / ultimate owner of the licensee" in the application form.

7. **Part 3 - Particulars of the Proposed Corporate to be Licensee's Partner / Director**

7.1 For corporate proposed to be licensee's partner / director, please complete Form 3B.

7.2 Applicant must list out all the proposed corporate partners / directors, and have to pay a fee for fit and proper person test for each of them. If Applicant has more than one corporate partner or director proposed, please make a photocopy of the page and fill in the information as an additional sheet for each proposed partner or director.

7.3 The proposed corporate shall make a statement that the corporate has consented to be a partner / director of the licensee subject to the approval to be granted by the CCE in respect of the application. The "Consent to act as a partner / director" must be signed by an authorized person acting on its behalf. The authorization letter is required to be submitted together with the application form.

8. **Part 4 – Declaration by the person who submits this application form (see Remarks in Part 4 of the form)**

The person who submits the application form should read the declaration in part 4 and fill in his / her particulars **without signing on it**. The application form is to be signed and stamped with the applicant company's chop in the presence of an authorized officer of the C&ED during an interview.

9. **Specimen of a Completed Application Form 4**

For further information on the requisite particulars and documents, the applicant should make reference to the "Specimen of Completed Form 4 – Application for Approval in respect of Persons Proposing to become Licensee's Partners / Directors / Ultimate Owners" at Appendix C.

## **Part C - Personal Information Collection Statement**

### **10. Purpose of Collection**

- 10.1 The personal data provided in the application form as well as any updates of them will be used for facilitating processing of applications / record purpose / record update and investigations for the enforcement of the Anti-Money Laundering and Counter-Terrorist Financing (Financial Institutions) Ordinance, Chapter 615.
- 10.2 It is obligatory for you to supply the personal data as required by the application form. If you do not provide sufficient information, we may not be able to process your application.

### **11. Classes of Transferees**

The personal data you provided in the application form as well as any updates of them may be disclosed to other Government departments / bureaux or organizations for the purposes mentioned in paragraph 10.1 above; or any third parties under section 49 of the AMLO; or where such disclosure is authorized or required by law.

### **12. Access to Personal Data**

You have the right of access to and correction of your personal data as provided for in the Personal Data (Privacy) Ordinance (PDPO). Your right of access includes the right to obtain a copy of your personal data provided in this form. In accordance with the provisions of the PDPO, we have the right to charge a reasonable fee for the processing of any data access request.

In case of doubt about legal issues, you should refer to the Anti-Money Laundering and Counter-Terrorist Financing (Financial Institutions) Ordinance or if necessary, seek assistance from your legal advisor.*

In determining whether a person is a fit and proper person, the Commissioner of Customs and Excise (CCE) must, in addition to any other matter that he considers relevant, have regard to the following:

- (a) whether the person has been convicted of —
  - (i) an offence under section 5(5), (6), (7) or (8), 10(1), (3), (5), (6), (7) or (8), 13(1), (3), (5), (6), (7) or (8), 17(9), 20(1), 61(2) or 66(3) of the AMLO;
  - (ii) an offence under section 14(1) of the United Nations (Anti-Terrorism Measures) Ordinance, Chapter 575 for a contravention of section 7 or 8 of that Ordinance;
  - (iii) an offence under section 25(1), 25A(5) or (7) of, or any offence specified in Schedule 1 to the Drug Trafficking (Recovery of Proceeds) Ordinance, Chapter 405; or
  - (iv) an offence under section 25(1), 25A(5) or (7) of, or any offence specified in Schedule 1 or 2 to the Organized and Serious Crimes Ordinance, Chapter 455;
- (b) whether the person has a conviction in a place outside Hong Kong —
  - (i) for an offence in respect of an act that would have constituted an offence specified in AMLO section 30(4)(a)(i), (ii), (iii) or (iv) had it been done in Hong Kong;
  - (ii) for an offence relating to money laundering or terrorist financing; or
  - (iii) for an offence for which it was necessary to find that the person had acted fraudulently, corruptly or dishonestly;
- (c) whether the person has persistently failed to comply with any requirement imposed under the AMLO or any regulation made by the CCE under section 51 of the AMLO;
- (d) whether the person, being an individual, is an undischarged bankrupt or is the subject of any bankruptcy proceedings under the Bankruptcy Ordinance, Chapter 6;
- (e) whether the person, being a corporation, is in liquidation or is the subject of a winding up order, or there is a receiver appointed in relation to it.
