**Circular to Money Service Operators**  
**Enforcement News**

**Money service operator convicted of operating without licence**

A woman was fined \$15,000 in total on 29 November 2017 at Eastern Magistrates' Courts for operating a money service without a valid licence.

Acting on information, officers of Customs and Excise Department (C&ED) found the woman operated the money service between 6 October and 7 November 2016 without a licence from the Commissioner of Customs and Excise.

Under the Anti-Money Laundering and Counter-Terrorist Financing (Financial Institutions) Ordinance which came into effect on 1 April 2012, a person who wishes to operate a remittance and/or money changing service is required to apply for a licence from the C&ED. Any person who operates money service without a valid licence commits an offence. The maximum penalty upon conviction is a fine of \$100,000 and imprisonment for six months.
