Circular to Money Service Operators Anti-Money Laundering / Counter-Terrorist Financing

(1) United Nations (Anti-Terrorism Measures) Ordinance

Further to our circular issued on 14 September 2012, an updated list specifying terrorists and terrorist associates designated by the United Nations Security Council ("UNSC") was published under section 4 of the United Nations (Anti-Terrorism Measures) Ordinance ("the UNATMO") (Cap.575) in the Gazette on 26 October 2012 (G.N. 6940 of 2012).

(2) US President's Executive Order 13224

Further to our circular issued on 24 October 2012, this is to inform you that the US Government has updated the list of designated individuals and entities issued under the US President's Executive Order 13224 ("Executive Order"). The updated information can be found on the website of the US Treasury. (http://www.treasury.gov/resource-center/sanctions/Programs/Documents/terror.pdf)

Money Service Operators (MSOs) should check the names in all of the above lists against their records, and report any transactions or relationships they have or have had with the named persons or entities to the Joint Financial Intelligence Unit.

MSOs are reminded that in accordance with the provisions of Chapter 6 of the Guideline on Anti-Money Laundering and Counter-Terrorist Financing, they should maintain a database of individuals and entities designated under the UNATMO, United Nations Sanctions Ordinance and Executive Order for client and transaction screening purposes.

Furthermore:

- for (1), MSOs are reminded to take all necessary steps to ensure compliance with the UNATMO and the Regulations made under United Nations Sanctions Ordinance.
- for (2), as the designated individuals and entities under the Executive Order may be updated by the US Government from time to time, MSOs are reminded to browse the website of the US Treasury regularly for the latest information.
